GENERAL INFORMATION

- All abstracts undergo peer review.
- Accepted abstracts will be assigned to oral or poster presentation.
- Outstanding trainee abstracts will be highlighted.
- **All accepted abstracts will be published EXACTLY as submitted in Hormone Research in Paediatrics.**

Important: Proofread before you submit

Accepted abstracts are published exactly as submitted, and changes are not allowed after the submission deadline. Review grammar, spelling, formatting, credentials, author details, and data carefully.

PREPARE YOUR ABSTRACT

Use this information as a practical checklist while drafting.

CORE FORMATTING REQUIREMENTS

Length Maximum 2,500 characters, including spaces. Title and uploaded figures/tables are excluded.	Title Use ALL CAPS. Keep it concise and avoid abbreviations.
Authors List credentials without periods (e.g., MD, not M.D.). Indicate if the first author is a student, resident, fellow, or junior faculty.	Abbreviations Define nonstandard abbreviations at first use; limit to three.
Drug Names Use generic names in lowercase.	Device Names Use generic names in lowercase.

RECOMMENDED STRUCTURE

1 OBJECTIVES State the study aims.	2 METHODS Describe design, population, interventions, and analyses.	3 RESULTS Report all outcomes, including statistics.	4 CONCLUSIONS State the main findings; avoid vague statements such as “results will be discussed.”

SPECIAL ABSTRACT TYPES

Case Reports Allowed. Suggested structure: Background / Case Report / Conclusions.	Clinical Trial Design Abstracts Permitted. Suggested structure: Objectives / Methods / Results (planned outcomes) / Conclusions.

Tables/Figures: May be uploaded as PDFs. If the patient is identifiable, authors must follow local institutional policies regarding informed consent and IRB review. If fully de-identified, consent requirements should be determined according to institutional guidelines.

AI-ASSISTED ABSTRACTS

Disclosure is required

Authors must disclose any use of AI tools in preparing the abstract, including the purpose of use (for example, editing, language refinement, or data analysis) and the proportion of text, if any, generated by AI.

Submitting authors remain fully responsible for accuracy and integrity. Failure to provide a clear disclosure may result in rejection.

SAMPLE DISCLOSURE STATEMENTS

- “AI tools (e.g. ChatGPT) were used for grammar and language editing only; 0% of the abstract text was generated by AI.”
- “AI tools (ChatGPT) were used to draft 20% of the background section. All content has been reviewed and verified by the authors.”

REVIEW + GRADING

- Abstracts will be peer reviewed using anonymous grading.
- Avoid institutional references, author names, or affiliations in the abstract text.

PRIOR PUBLICATION POLICY

Abstracts must be original. At the time of submission:

- They must not have been presented at a national or international meeting.
- They must not contain previously published data.

TIPS FOR STRONG RESEARCH ABSTRACTS

- ✓ Report outcomes, not just program descriptions.
- ✓ Provide full results, not just planned analyses.
- ✓ Include details on statistical methods, not just p-values.
- ✓ Negative findings are welcome and valuable.

SUBMISSION + FEES

FEE \$50 USD per abstract. The fee is used to support fellow travel scholarships.	FIGURES / TABLES One PDF file may be uploaded.
PORTAL Login to start, edit, and submit. Abstracts may be saved as “Pending” and completed later.	REVIEW STATUS Only abstracts marked “Submitted” will be reviewed.
Final pre-submission check Confirm your abstract is within the 2,500-character limit, uses the required title and author formatting, includes complete results, and has been proofread carefully. If AI tools were used, include the required disclosure. If human/animal research is involved, ensure the appropriate IRB/ethical approval or exemption is in place.	

AFTER SUBMISSION

Responsibilities, policies, and presentation expectations for accepted abstracts.

PRESENTER RESPONSIBILITIES

Correspondence: All correspondence will be sent **only** to the submitter’s email. PES will not contact co-authors directly. The submitter must share information with co-authors and confirm the presenting author(s).

Submitter Role: The submitter is responsible for submission, communication with co-authors, and final confirmation of presentation.

Registration + Travel: All presenters must be registered for the Annual Meeting and are responsible for travel and lodging costs.

Presenter Substitution: Substitution of presenters must be requested in writing to PES by the specified deadline.

POLICIES

Conflict of Interest	Disclose funding from proprietary organizations (e.g., pharma/device companies).
IRB / Ethics	All human/animal studies require IRB/ethical approval or exemption letter. Case reports must have patient consent if identifiable.
AI Use	If AI tools were used to generate content, disclose in the Methods section. Authors remain responsible for accuracy.
Withdrawal	Requests to withdraw must be submitted in writing before April 1, 2027.
Acceptance Policy	By submitting, you affirm compliance with PES abstract requirements, including IRB/ethics approval, disclosure of conflicts, and presenter responsibilities. Accepted presentations may be recorded and shared by PES for educational purposes.
